



The Basic Oregon Workers' Compensation Certification Course

Previously offered by Jerry Keene/OWCI

Thank you for your interest in our Basic Workers' Compensation course for Oregon claims examiners. This sheet provides answers to the most frequent asked questions, including this year's course schedule.

INSTRUCTORS The course is presented by Reinisch Wilson Weier shareholders with decades of experience specializing in workers' compensation litigation defense. Associates of the firm conduct lab sessions following the principal lectures to provide special mentoring and to go over study questions that are specifically designed to prepare students for information covered in the certification examination.

This course was previously led by Jerry Keene, founder of the Oregon Workers' Compensation Institute. Jerry taught the course from 1991, when Oregon first began to require examiner certification, until his teaching retirement at the end of 2017.

2018 COURSE DATES Each course consists of 10, three-hour sessions on Tuesdays and Thursdays unless otherwise noted:

- Spring Course:
2:00 to 5:00 p.m. on March 6, 8, 13, 15, 20, 22, 27, 29, April 3, 5 (exam)
- Summer Course:
2:00 to 5:00 p.m. on July 10, 12, 17, 19, 24, 26, 31, August 2, 7, 9 (exam)
- Fall Course:
2:00 to 5:00 p.m. on October 2, 4, 9, 11, 16, 18, 23, 25, 30, November 1 (exam)

Attendance: Students may not miss more than one of the first 8 class sessions to remain eligible to take the certification exam. Replays of recorded lectures will be available for course participants to make up missed classes.

CERTIFICATION Oregon law requires prospective examiners to score 80% or more on an examination that tests familiarity with and ability to "navigate" workers' compensation administrative rules and statutes; the ability to perform basic processing functions, and familiarity with the rules governing IME interactions. The Basic Workers' Compensation course and exam are designed to satisfy these requirements. Approximately 85% of students historically have passed, but we cannot and do not guarantee passage. Those participants who pass will receive all

documentation necessary to satisfy Oregon law governing certification. Course participation will also satisfy all 24 hours of continuing education credits (including "rules update" and IME interaction credits) necessary to renew certification for Oregon examiners.

TUITION The course tuition is \$525, which includes 9 lectures and lab sessions, exam administration, the nearly 300-page course textbook, a printed copy of Oregon's workers' compensation statutes (ORS Chapter 656) and the documentation necessary for Oregon certification. Because the course often fills, the tuition is payable in advance and is non-refundable unless an alternate is found to replace students who cancel.

We accept checks sent before the first class, delivered on the day of the class, or credit card payments online.

MATERIALS Tuition includes the textbook, a printed copy of Oregon's workers' compensation statutes (ORS Chapter 656) and a set of study questions to assist with exam preparation. Students must obtain their own copy of the current version of Oregon's workers' compensation administrative rules (OAR Chapter 436), which may be downloaded at <http://wcd.oregon.gov/laws/Pages/index.aspx>. Download the option marked "complete set".) Participants must also bring a three-ring binder (two-inch size) to hold the printed materials. We also recommend two sets of tabbed page dividers for the OAR Divisions and for the course book chapters, respectively. Students must also obtain a pocket calculator (other than one in a cell phone) for classes and the exam.

COURSE METHODOLOGY AND STUDENT TIME COMMITMENT The course consists of 9 lectures based upon reading assignments in the 13 textbook chapters, including a post-class discussion of study questions that students complete in advance for each class. Students should plan to devote at least 4 hours a week to outside study in addition to attending classes. Approximately a half-hour of each class will be devoted to a discussion of study questions designed to help prepare for the examination. At the end of Class No. 8, a Practice Examination is distributed to be completed for discussion in Class No. 9. The actual certification exam is administered in Class No. 10.

DIRECTIONS TO THE REINISCH WILSON WEIER TRAINING CENTER Our Training Center is located in near Washington Square Mall at 10260 SW Greenburg Road, Suite 1250, Portland OR 97223.

Directions from Hwy 217 Northbound or Southbound. Take the Greenburg Road exit and turn east (towards Washington Square). Just past the overpass, turn right onto Oak Street. Take the second driveway on the left. Park free in the parking structure to your right on any floor. Each floor has a stairway or entrance directly into the Lincoln Tower lobby. Enter the lobby from the parking structure and proceed to the first set of (four) elevators. Come to the 12th (top) floor and look for the sign.
